**WYOMING STATE FAIR
PIG 'N MUD WRESTLING
2017 RULES**

1. **Teams consist of Four (4) members.**
2. **All contestants MUST sign a release form. Anyone under age 16 MUST have a parent's signature before the entry form will be accepted.**
3. **All players must wear shirt, pants, shorts and shoes for safety reasons.**
4. Sponsor or team captain is responsible for the actions of the team.
5. **No player may use gloves, spikes, hooks, or any other object to help catch a pig.**
6. There will be 2 players on each side of entry gate.
7. All players must have one hand on the fence between entry gate and orange ribbon on fence.
8. Pig must be put in the barrel **butt** first.
9. No hitting pig to start or otherwise harm the animal.
10. Barrel must be upright at all times.
11. There will be a one minute time limit on each match.
12. All players must raise both hands in the air to complete the match.
13. Players must stay and help unload the pig out of the barrel.
14. **THE JUDGE'S RULING IS FINAL!!**
15. All contestants **MUST stay out** of the grandstand seating areas and grandstand restrooms after competing.
